Throat and breast were orange-cinnamon with an incomplete dark gray breast band. Band extended about half way across breast. Back of bird was dark gray fading to medium gray on the rump. Tail was dark gray and medium length. Wings were dark gray with two prominent cinnamon wing-bars. Primaries and secondaries were also mottled with cinnamon. Flanks were mottled gray and cinnamon. Belly was white. Undertail coverts were mostly white with some mottling of gray. Bill was black and straight and of medium length.		
Describe the bird's (birds') call(s) and/or song(s), if noted: Not heard.		
SIMILAR SPECIES – This is another critical part of your report. Please discuss how you eliminated similar species from consideration: Robin is probably most similar specie with many differences. Eyebrow instead of eyering, partial breast band, different breast color, wing bars, bill blackish not yellow, no white tail corners, etc.
