Describe the bird's behavior (e.g. flying, feeding, or habits used in identifying):

The bird was first seen in a very large flock of yellow-rumped warblers <sup>(both myrtle & Audubon's)</sup> (7+♂'s). The flock was moving through the canopy and understory of old cottonwood trees. The whole flock was busy feeding along the branches and amongst the leaves.

Describe in detail the bird's relative size, overall shape, plumage and color pattern. Include details of bill, wing and tail shape. Give particular emphasis to marks you used to identify the bird. Reference to its resemblance to field guide descriptions and illustrations is not enough. Describe only what you actually observe in the field:

I was trying to check every yellow-rumped warbler in this large flock 20± of birds when I saw this bird with a yellow face and black throat. I called the other 2 observers and together we pieced together various particulars of the bird (though finally we all saw the whole bird) and saw the wing bars. George said the underparts lacked any streaking or yellow. I looked up the head pattern. Then the bird flew. We found it twice after that and were able to see

Description (continued):

A bird the size of yellow-rumped Warbler with a yellow face dark eye thin bill and black throat. We were finally able to see the nape which was black with some of the black extending onto the back of the head. The back was darkish and the 2 pale wing bars were apparent. The underparts were whitish with no streaking or yellow visible.

Describe the bird's song and call, if given, including method of delivery, (i.e. from perch, in flight, duration):

Describe the general and specific habitat in which you observed the bird:

Fountain Creek Regional Park - Riparian habitat along Fountain Creek - old Cottonwoods just beginning to leaf out

How did you eliminate similarly appearing species?

Black-throated green has black streaks on sides and yellow underbelly  
golden-cheeked Warbler has black line through eye and black streaks on side  
Townsend's Warbler has black around the eye and black streaks on side  
Townsend's x Hermit Warbler has streaking on the sides and yellow wash on breast -

Our conclusion was HERMIT WARBLER - because there was no black on the face  
no streaking on the sides  
no yellow on breast or belly

What is your prior experience with this and similarly appearing species?

I have only seen 1 other Hermit Warbler - Carmel Valley Sept 1989
