The bill was rather heavy looking with a bulbous tip, dark in color. The throat was white, as was the chest. The sides of the neck had a yellow wash to them. The mantle, wings and tail were dark, without any obvious elongated central retrices. The open wing showed a white patch at the base of the primaries on the upper wing. On the lower wing, two white patches were noticed, one at the base of the primaries and another at the base of the greater primary coverts. The legs and undertail coverts were not seen.
