LIGHT CONDITIONS [QUALITY; DIRECTION RELATIVE TO BIRD(S); POSITION]: Weather was clear with bright sunlight. Sun was essentially overhead.

OPTICAL EQUIPMENT USED: Bushnell 10x binoculars; Bushnell Spacemaster scope (20-45x)

GENERAL AND SPECIFIC HABITAT IN WHICH THE BIRD(S) OCCURRED: Small shallow pond in a cattle pasture.

The bird was standing almost stationary in the shallow water during the entire observation period

DETAILED DESCRIPTION OF THE BIRD(S) [INCLUDE OVERALL SIZE AND SHAPE; PLUMAGE DETAILS INCLUDING HEAD, THROAT, UNDERSIDES, NAPE, BACK, WINGS, AND TAIL; AND COLOR AND SHAPE OF BILL, LEGS, EYE, ETC. While looking at a Red-necked Phalarope in my scope, I noticed a "different" larger shorebird in the background of my field of view. The bird was approximately Willet-sized, and was immediately identified as a godwit by the long, bicolored upturned bill. What initially caught my eye was the pale grayish-appearing head contrasting with a blackish back and dark chestnut red underparts with fine black barring, ruling out Marbled Godwit. Identification as Hudsonian Godwit was confirmed when I was able to observe the black tail, white upper tail coverts, and blackish wing linings. Based on appearance, I concluded that this was a male Hudsonian Godwit in alternate (breeding) plumage.

SIMILAR SPECIES AND HOW THEY WERE ELIMINATED:

Marbled Godwit (the "expected" godwit in CO): larger than HUGO; overall buff-brown color with cinnamon wing linings; tail buff-brown with black barring; upper tail coverts also buff-brown (not white). Bar-tailed Godwit: does not have black tail, white upper tail coverts, or black wing linings Black-tailed Godwit: in alternate plumage, head and neck are chestnut colored; wing linings are white; bill is usually straighter than other godwits

The Bar-tailed and Black-tailed Godwits are basically Eurasian species, and can essentially be ruled out based on historic range alone, occurring in the lower-48 only casually along the coasts (even though one can always hope; I did check my ID several times to make sure it was not a Black-tailed Godwit).

PRIOR EXPERIENCE WITH THIS AND SIMILAR SPECIES:

Hudsonian Godwit: I have seen this species twice before in CO (May 1988 & May 1992; coincidentally, the one seen in 1992 was on this same pond); I have also seen them in AK &NY

Marbled Godwit: CO (several seen every year beginning in 1981); Have also seen it in AK (1st record for Gambell, 6/95), CA, FL, SC, and TX

Bar-tailed Godwit: AK (1995) Black-tailed Godwit: None
