It then began to forage in the same tree, flew to another tree and then we lost sight of the bird. Describe the bird in detail. This is the most important part of this report. The bird was short tailed looking and appeared to be without neck (RC Kinglet like). The crown was gray, darker than the pale gray nape and back. The wings were unbanded and about the same color as the back with the primaries beening a touch darker. The tail was the color of the back. The head had a pale white supercillium, a dark eye with a faint dark eye stripe in front and behind the eye. The eye stripe did not reach the bill.

The bill was vireo like, dark on top and light below. The throat and breast were a very pale yellow, as were the under tail coverts. The belly was off

Describe bird's call or song: none heard

Discuss similar species and how you eliminated them: The plain wings eliminates most vireos, the face pattern eliminates Gray Vireo. The supercilliun lacked a distinct black border, along with a pale gray back eliminates Red-eyed Vireo. The problematic remaining bird was Warbling vireo. I felt this was a P. Vireo because of the following; Yellow in the throat, dark feathers in front of the eye and the jiz (short-tailed and the lack of a neck look to the bird).

What is your prior experience with this and similarly appearing species? I have seen some in Minnesota (spring) and only fall juvs in Colorado.
