They generally come to the feeder three or four times a day. There are now only 5 birds and they always come together, not individually.

This is a small dove with gray-buff upperparts, scaly grayish white under parts and a long square tail. The dark edging on its feathers give it a scaly or scalloped look on its back, wings and breast. These marks are the only dark marks on the wing feathers, i.e., no spots or splotches. The bird has small black marks (vertical slashes, not easy to see) on the flanks. The feet are pink, the beak is dark and slightly curved downward and the eyes are dark. When it flies, the primaries are chestnut or rusty colored and they do have a slight winnowing sound heard especially when the bird begins its flight. In flight, the dove shows gravish brown down the middle of the long square tail, with black feathers on either side and then white outer tail feathers. These birds are quite gregarious and regular in their feeding habits.

SIMILAR SPECIES -- This is another critical part of your report. Please discuss how you eliminated similar species from consideration. Common Ground Dove would be the closest similar species but it has a shorter, rounded black tail with white only on corners. Bird does not have "scaly" appearance, as do the Incas. The bird is smaller than Inca Dove. No black spotting on wings. Smaller than a Mourning Dove, has rusty primaries which Mourning Dove does not.
