Vermilion Flycatcher Pyrocephalus rubinus

Observed: 0915-1130. Found by Mark Chavez; also seen by Warren Finch, Jim Schmoker overcast, then sun; frontal sun at 25-100 ft. Total observ. time 20 minutes.

Equip.: 8 x 56 bino, Kowa scope

Hab./behavior: urban park with small, dammed lake fringed with aspen, willows, pines, cottonwoods, open grassland. Seen flying from willows to aspen trees, singing in flight; "roller coaster" style.

Description: small flycatcher with unmistakable plumage, bright to light crimson from chin to undertail coverts, slight buff tinge to sides of breast; short-tailed, dark brown/black; nervous upward flick when perched. Under remiges (primaries, secondaries) white contrasting with dark wing linings, legs black.

head: small, pointed, black bill; crimson crest and face, very dark brown colored mask from lores through dark eye, extending to hind crown and nape, connecting to dark brown mantle. Wings same dark brown; secondaries and greater, median s. coverts and tertials narrowly lined with buff edges. Lower tips of scapulars had pink/ buff "tuft". Primaries black.

Vocal: singing "da deet da dee " in flight.

Similar species: none. Have seen VEFL many times.

I had heard of the presence of a male Vermilion Flycatcher at Belmar City Park via Cobirds and opted to chase it. I arrived at the park in late afternoon and spent at least an hour searching for the bird to no avail. While birding the north shore of the pond in the center of the park. I saw another birder waiving that he probably had the bird on the island in the center of the pond. As I approached neared the island, I quickly saw the bird. The following were traits of the bird. The bird was small, being roughly 6 inches in size, with a large head with pointed crown, short wings, and relatively short, square-tipped tail. The breast was deep and the bird was generally perched in an upright fashion. The bill was somewhat short and black. The head was mainly a bright red except for a blackish face mask that extended across the lores, widened slightly through the eye and auricular region and broadened greatly toward the hindneck. The lower head, throat, breast, flanks, vent, and undertail coverts were the same bright red as the majority of the head. The nape, back. wings, and rectrices were generally a blackish-brown, except for a very thin whitish tip to the distal end of the rectrices and very faint, whitish wingbars along the tips of the median and greater coverts. The subject bird would occasionally sally over the water, returning generally to the same perch following its foraging.

## Describe bird's call or song: None heard

Discuss similar species and how you eliminated them: No other small bird in North America has the same color pattern as that of an adult male Vermilion Flycatcher. Scarlet tanager has a combination of red and black, but is larger with a thicker bill, with red upperparts and lack of black in the face. Red Warbler, a Central American species, would be highly improbably of occurring in Colorado and lacks the blackish face mask and upperparts of the subject bird. Northern Cardinal is a larger species with much thicker bill and also lacks the black upperparts displayed by Vermilion Flycatcher.

What is your prior experience with this and similarly appearing species? Have observed many others in Texas, New Mexico, Arizona, and Mexico. Have also observed a few other birds in Colorado.
