Describe the bird's behavior: Actively feeding in large elms and other shade trees in residential area. Feasting on many insects gleaned from the trees. Healthy appearance.

Describe the bird (what you actually saw): Brilliantly red, somewhat chunky bird with black wings and shortish black tail, pale bill, dark eye, very little body molt.

Describe the bird's song and call if heard: Did not vocalize.

Describe the habitat in which you observed the bird: Residentail area with mature shade trees, close by Long Pond.

How did you eliminate similarly appearing species: Did not have bill size, shape or color of Summer or Hepatic Tanagers. Wings and tail fully oldly b lack, not dull and washed with color of Summer and Hepataic Tanagers. Back, Breast and belly were pure, bold red, not brownish or rosy. No cheek patch like Hepatic Tanagaer.

Red Crossbill - no way.

Vermillion flycatcher - our bird was larger, had no mask, its back was red, its wings/tail very dark black, not brown. Also had 'tanager' bill.

What is you prior experience with this and similarly appearing species: Have seen Summer Tanager in Tucson and Belize (1994) and Hepatic in Mexico (1996). Sightings were lengthy, but I only saw a few birds. Red Crossbill I am very familiary with, having hordes of them at my home each year. Vermillion Flycatcher I've seen in Arizona and Belize (1994). Have no experience with Summer Tanager, but it's conspicuous plumage was a great I.D.

List books if they helped in your identification: Even with this bird's conspicuous plumage, we looked in National Geographic Field Guide to the Birds of North American and Peterson's Western Birds.
